

PRELIMINARY MARKET CONSULTATION (AGP GAR)

Subject: supply of GPS-GSM for bird tracking

The Head of BIO-CFSD, Dr. Piero Genovesi declares that ISPRA needs to purchase a supply of GPS-GSM tags under the Art 1, comma 2, lett. a) del D.L. 76/2020 converted into L. n. 120 on 11/09/2020.

The total value is estimated in 137.712,00 € Vat excluded. Estimates exceeding this total valued will be not accepted. The awarded amounts will be those resulting from the tender.

In accordance with the Italian Law (dell'art. 54 del RD 23 maggio 1924, n. 827 e s.m.i. e dell'art. 103, co 11, del d.lgs. n. 50/2016), in case the Supplier applies a price improvement, ISPRA reserves the right to exempt the Supplier from providing a security deposit as a guarantee of the supply.

2. SUBJECT OF THE TENDER

The subject of the tender is the supply of GPS-GSM tags to deploy on Northern lapwing (*Vanellus vanellus*), Mediterranean gull (*Ichthyaetus melanocephalus*), Black-headed gull (*Chroicocephalus ridibundus*), Eurasian woodcock (*Scolopax rusticola*), Egyptian vulture (*Neophron percnopterus*), and Golden eagle (*Aquila chrysaetos*), as specified in the Technical Specifications documents herewith enclosed (**CTL1E – Lotto 1 and CTL2E – Lotto 2**).

3. DURATION OF THE CONTRACT

A contract will be stipulated for each lot. Each contract will take effect from the date of the report of start of activity. Tags must have been tested and delivered within 90 (nighty) days from the start of the contract.

4. SELECTION CRITERIA

Companies interested in this procedure must meet the following requirements:

- a) The company must not be subject to specific restrictions or legal impediments to conclude contracts with public administrations (under Article 83 comma 3 del D. Lgs. n. 50/2016).
- b) In compliance with the procedures in force in the Country of residence, the Company must be registered in one of the professional or commercial registers of the Country of residence (registers, lists, and analogues, recognized by the legal system under Article 83 comma 3 del D. Lgs. n. 50/2016).

The possession of the above requirements must be certified following the prescription of D.P.R. n. 445/2000.

Criteria for the award of the contract for each lot are:

1. Best price.
2. Compliance with requested technical specifications.

5. OFFER SUBMISSION

The supplier is requested to send the best offer for either one or both lots by means of the form attached (Annex AL – Lotto 1 and Annex AL – Lotto 2), that must be filled out in all sections, stamped and signed in full by the legal representative at the last page.

Fluctuations of the monetary values affecting the price of the service shall be entirely borne by the supplier.
